On behalf of Mayo Clinic's Lab Medicine and Pathology department and Mayo School of Continuous Professional Development, we are writing to request your consideration to exhibit at the ***Mayo Clinic Pathology Update 2017: A Tribute to the Career of Kevin O. Leslie, MD***. This continuing medical education activity will be held Thursday to Saturday, January 26 – 28, 2017 at Waugh Auditorium in the Education Center on Mayo Clinic's Hospital campus in Phoenix, Arizona. **Purpose of Form**
