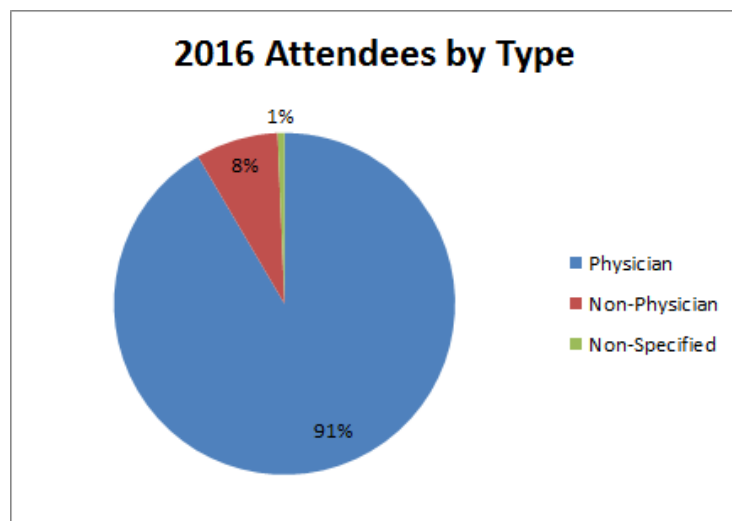
Exhibitors will be placed in the Zurich Foyer, located just outside the main meeting room with the refreshments.
