Course Description

Ethical dilemmas related to patient care can be associated with medical, psychosocial, ethical, and spiritual challenges for health care team members. This course will be highly practical, action-oriented and will focus on:

- Helping attendees to identify clinical ethical dilemmas in daily practice.
- How to effectively determine patient preferences and appropriate goals of care.
- Developing a coordinated, consistent approach to ethical dilemmas to reduce both the frequency of occurrence and stress among providers, patients and their families, and the community.
- Creating and implementing an ethics consultation service in your practice based on the four quadrant approach.

Course Learning Objectives

Upon conclusion of this program, participants should be able to:

- Explain requirements for effective ethics consultation.
- Prepare local training programs for ethics consultants.
- Describe the concepts to consider when responding to a request for an ethics consultant.
- Identify common clinical ethical dilemmas.
- Identify approaches to resolving clinical ethical dilemmas.
