Pre-Course:

- Three practice self-assessments (200 questions each) are included as part of your registration fee.
- Practice self-assessments will be available May 1 June 20, 2018 at 11:59 PM.
- Attendees will be notified by e-mail when the practice self-assessments are available.
- The practice self-assessments are not eligible for credit.

Live Course (June 21-23 2018):

• Self-assessments will **not** be available to attendees during the live course.

Post-Course (June 23, 2018 at 5:01 PM – July 23, 2018 at 11:59 PM):

- Three self-assessments (200 questions each) will be released on June 23, 2018 at 5:01 PM.
- Attendees will have two attempts to get at least 80% on each of the three self-assessments.
- The self-assessments will be available to complete and claim credit until July 23, 2018 at 11:59 PM.
- After July 23, 2018 at 11:59 PM, the self-assessments will be available **for practice only** (no credit will be awarded) through March 1, 2019.

Frequently Asked Questions:

- Is there an additional fee to obtain ABPN MOC?
 - No, the fee is included as part of your registration for the live event.
- How many Self-Assessment Credits can I obtain for completing all three of the MOC selfassessments?
 - Attendees can claim up to a maximum of 72 Self-Assessment credits (24 Self-Assessment credits/test).
- How many attempts do I have to complete the exams?
 - You have two attempts to complete each of the three self-assessments.
- What constitutes as a passing score?
 - Attendees must get at least 80% to be awarded credit for the self-assessments.
- When will the self-assessments be available?
 - The practice self-assessments will be available May 1 June 20, 2018 at 11:59 PM. Attendees will receive an e-mail when they are available.
 - The self-assessments will be available for credit from 5:01 PM June 23 July 23, 2018 at 11:59 PM. This timeframe is determined by ABPN's 30-day reporting requirement and cannot be extended.
 - The self-assessments will be available again **for practice only** (no credit) after 12:59 PM on July 23, 2018-March 1, 2019.
- How do I claim MOC credit?
