### American Board of Psychiatry and Neurology (ABPN) Maintenance of Certification (MOC) Self-Assessment Information

#### **Pre-Course (for Practice):**

- Practice self-assessment exams will be **available May 1 - June 19, 2019 at 11:59 PM Central Time.**
- Three practice self-assessments (200 questions each) are included as part of your registration fee.
- You are not required to complete these self-assessments, they are optional.
- The practice self-assessments are not eligible for credit.

#### **Live Course (June 20-22, 2019):**

- Self-assessments will **not** be available to attendees during the live course.

#### **Post-Course (for ABPN MOC Credit):**

- Three MOC self-assessment exams will be **available June 22, 2019 at 6:01 PM - July 23, 2019 at 11:59 PM Central Time.** This timeframe is determined by ABPN's 30-day reporting requirement and cannot be extended.
- The three MOC self-assessment exams (200 questions each) are included as part of your registration fee.
- You are not required to complete these exams, they are optional.
- Attendees will have two attempts to get at least 80% on each of the three self-assessments.
- You may take 1, 2, or all 3 exams.
- Each exam is worth 24 MOC SA credits, with a possible 72 MOC SA total credits awarded for passing all three exams.
- After July 23, 2019 at 11:59 PM, the self-assessments will be available **for practice only** (no credit will be awarded) through March 1, 2020.

- Practice self-assessments will be **available July 23, 2019 at 6:00 AM – March 1, 2020 Central Time.**
- The three practice self-assessment exams (200 questions each) are included as part of your registration fee.
- You are not required to complete these exams, they are optional.
- The practice self-assessments are not eligible for credit.

### **Frequently Asked Questions:**

- **Is there an additional fee to obtain ABPN MOC?**
  - No, the fee is included as part of your registration for the live event.
- **How many Self-Assessment Credits can I obtain for completing all three of the MOC self-assessments?**
  - Attendees can claim up to a maximum of 72 Self-Assessment credits (24 Self-Assessment credits/test).
- **How many attempts do I have to complete the exams for self-assessment credit?**
  - You have two attempts to complete each of the three self-assessments.
- **How many attempts do I have to complete the exams for practice?**
  - You can take them as many times as you want for practice (no credit).
- **What constitutes as a passing score?**
  - Attendees must get at least 80% to be awarded credit for the self-assessments.
- **How do I claim MOC credit?**
  - We will report credit to the ABPN by the end of July, 2019 for learners who passed the exams.
