BUSINESS VISA REQUIREMENTS:

- A clear scanned color copy of the Applicant's Passport (Passport MUST be valid for 6 months at least).
- Guarantee letter from the Local company (company from Bahrain) to confirm the guest is officially working with or related to the company and company holds the responsibility in case the guest violated the immigration rules.
- Completed Visa Application Form with credit card authorization along with copies of the credit card (both sides).
- Confirmed reservation at the gulf hotel. Chargeable once visa is approved.
- Visa application for Corporate Company Guest only who will be staying in the hotel. If guest will stay out, the hotel has the right to cancel the application and charge the amount. The Visa is valid only for single entry and the duration of stay is limited to 7 days from the date of arrival. Visa processing will take 7-10 working days, therefore all the above requirements must be received 10 working days prior to arrival date.
- Please note that it will be one night room charge in case of "No show or cancellation" and hotel have right to cancel the entry visa in case of guest didn't stay at the hotel within the validity of entry visa.**
