

## **Headache Management: Creating Migraine Warriors Online Course**

### **Activity Description**

This online course will provide learners with an update in the diagnosis and management of migraine and other headache disorders. Content covered will arm primary care and sub-specialist practitioners in diagnosing and treating headache disorders, including migraine and others.
