# **Woman's Health Update Online Course**

## **Activity Description**

This online course offers discussions on a variety of health issues that are unique to women. It highlights medical conditions that may cause different symptoms in women or affect women differently than men and thus, may require different treatment or prevention protocols. Updates include common breast symptoms, breast reconstruction, UTIs, diverticulitis, premenstrual dysphoric disorder, COVID, monkeypox infections, menopause and mood, premature menopause, androgens, and troubleshooting hormone therapy. In addition, several topics on sexual health are covered including female sexual physiology, and causes and management of sexual difficulties. Many other topics discussing cosmetic concerns, sports injuries, weight management, and regenerative medicine are explored.

### **Target Audience**

This course is designed for primary care physicians/practitioners, general internists, gynecologists, specialists in preventative care, and other healthcare professionals (PAs, NPs and RNs) who have an interest in women's health.

## **Learning Objectives**

Upon conclusion of this activity, participants should be able to:

- Analyze an approach to breast cancer screening with newer imaging modalities
- Analyze an approach to breast cancer risk assessment utilizing a personalized genomic approach
- Recognize recent approaches in infectious disease care including UTI and novel infections
- Review care of the aging patient, including screening, and osteoporosi
- Recognize current strategies in weight management and aesthetic dermatology
- Describe updates in gastrointestinal issues, migraine and mental health
- Recognize the role of menopausal hormone therapy for managing perimenopausal and menopausal symptoms
- Describe a plan to manage the side effects of menopausal hormone therapy
- Recognize a plan for the management of female sexual dysfunction and pelvic pain
- Describe the role of sex therapy after cancer treatment
- Recognize the various treatment options of pelvic organ prolapse
- Recognize the racial disparities in the prevalence and management of uterine fibroids
