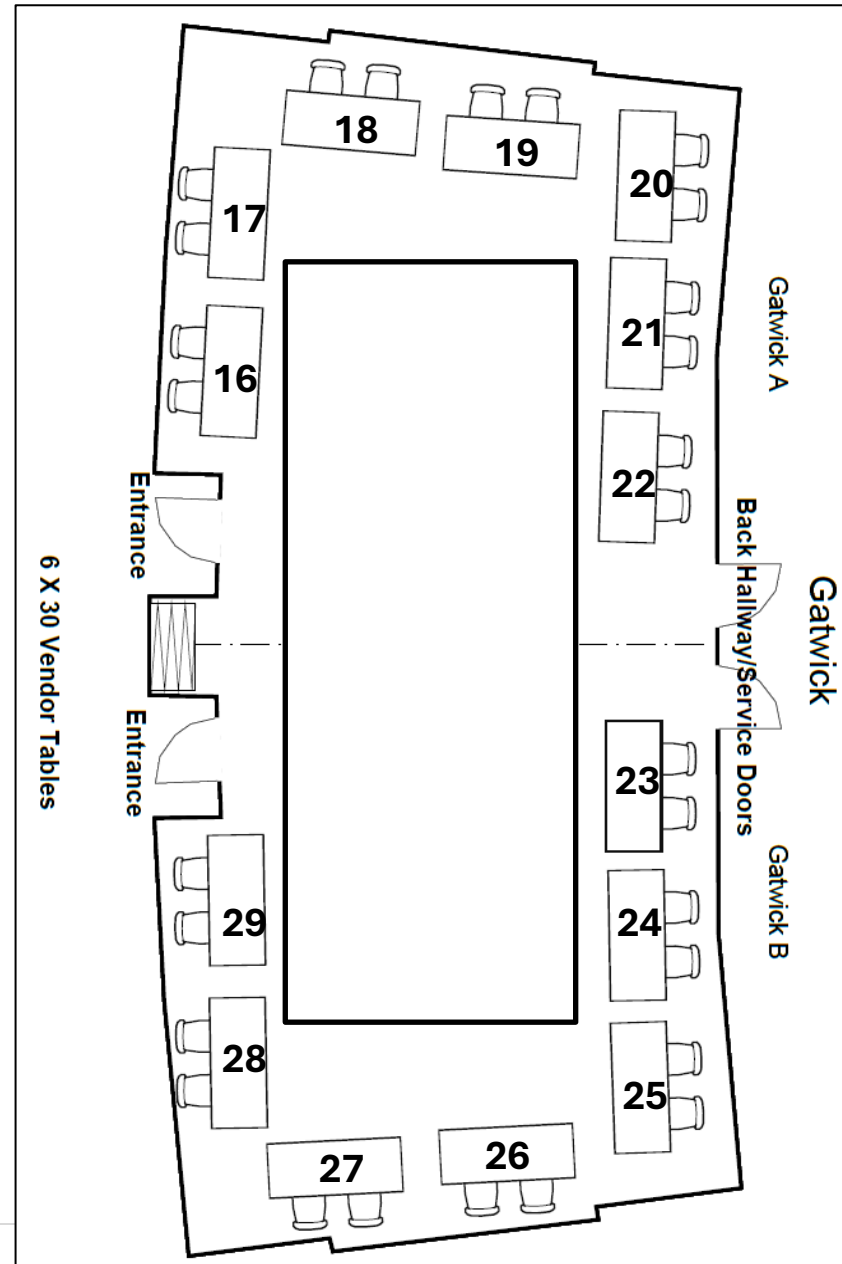
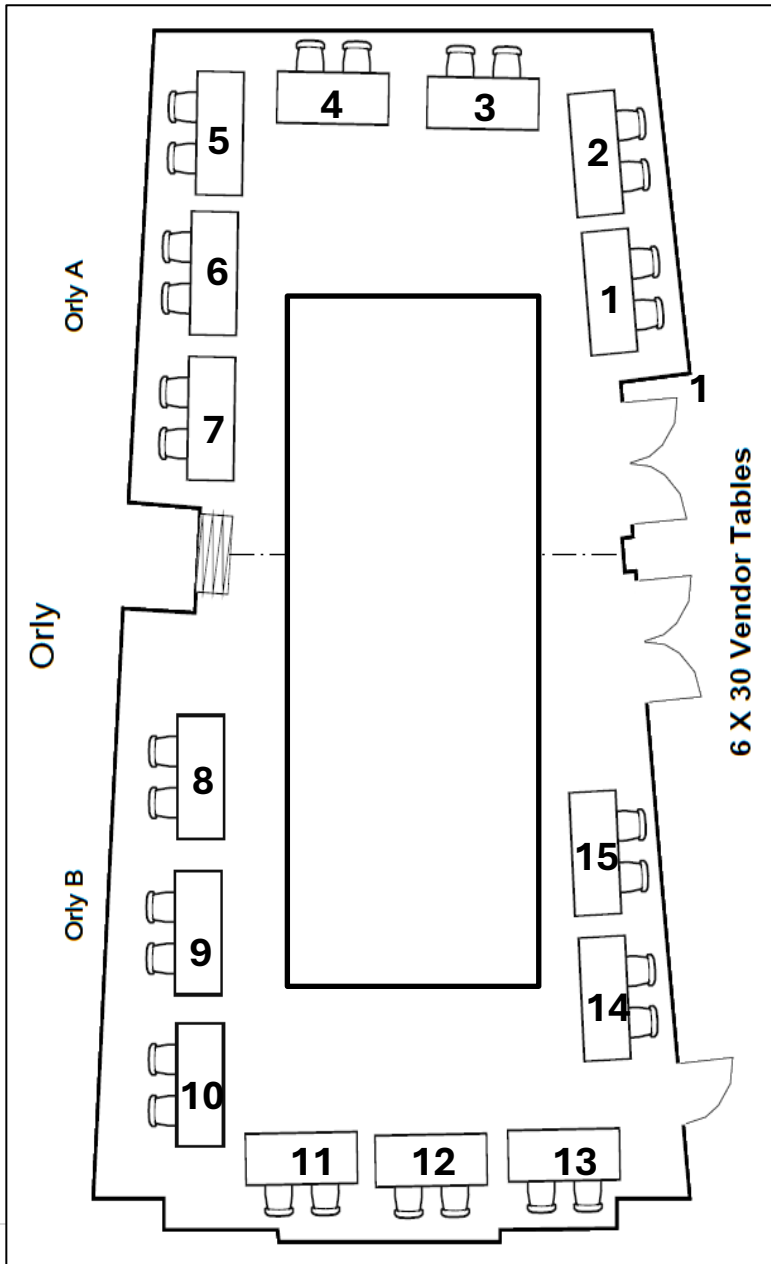

- **From the West:** Take I-70 east to the Natural Bridge Road exit. The hotel is immediately after the first stop light on the left.
- **From the East:** Take I-70 to 170 South. Take the exit to Natural Bridge Road. Turn left (west) on Natural Bridge Road. The hotel entrance is approximately one mile west on the right.
- **From the South:** Take 170 North. Take the exit to Natural Bridge Road. Turn left (west) on Natural Bridge Road. The hotel entrance is approximately one mile west on the right.
- **From the North:** Take 170 South. Take the exit to Natural Bridge Road. Turn left (west) on Natural Bridge Road. The hotel entrance is approximately one mile west on the right.



# Rules and Regulations

In applying for exhibit space, exhibitors agree to abide by the following regulations:

## Exhibit Regulations

- Each exhibitor is responsible for compliance with the Americans with Disabilities Act (ADA) within its booth and assigned space.
- The attire of exhibit personnel should be consistent with the professional atmosphere of the convention.
- Exhibitors' demonstrations may not interfere with normal traffic flow or infringe on neighboring exhibits. Demonstrations are not permitted outside of the exhibitor's assigned booth space.
- Exhibitors cannot canvass or distribute advertising material outside their booth space.
- Canvassing or marketing any products or services in any part of the exhibition hall or meeting rooms by anyone representing a non-exhibiting firm is strictly prohibited.
- Exhibit space subletting and sharing are not permitted unless they are within divisions of the same company.
- The exhibitor is responsible for having all licenses, permits, and/or registrations required by the venue, city, municipality, and/or state and complying with all applicable tax laws.
- You must read and agree to the terms listed in the Exhibitor Prospectus.

## Terms and Conditions

- EXHIBITOR agrees that all promotional activities and materials must be appropriate for a professional audience and must not interfere with the event experience. Product-promotion materials and advertisements must be confined to the designated exhibit space. Promotional activities (live or digital) must not disrupt event programming or other exhibitors.
- EXHIBITOR may distribute educational and promotional materials only within their assigned exhibit space.
- All exhibit fees must be disclosed to and processed through the PROVIDER. No additional payments, gifts, services, or incentives may be provided to event organizers, planning committee members, speakers, or affiliated personnel.
- PROVIDER will assign exhibit space and reserves the right to relocate or reassign space at its discretion to ensure a balanced and professional exhibit environment.
- Completion of this agreement constitutes a binding commitment. EXHIBITOR agrees to remit full payment of all fees by the event date unless otherwise arranged with the PROVIDER. PROVIDER reserves the right to deny exhibit space in the event of nonpayment or violation of these terms.
- If cancellation occurs **45 days or more** before the event, PROVIDER will refund the exhibit fee minus a \$300 processing fee.
- If cancellation occurs **less than 45 days** before the event, the full exhibit fee is due and non-refundable.
- EXHIBITOR is expected to maintain professional conduct throughout the event. PROVIDER reserves the right to remove any exhibitor for behavior deemed inappropriate or disruptive, without a refund.

## Liability

- Missouri-Illinois Public Health Officials, APIC Chapter 73, nor the Mayo Clinic Center for Tuberculosis shall be responsible for injury, loss, or damage that may occur to the Exhibitor or his property from any cause whatsoever, prior to, during, or after the period of the Exhibit. The Exhibitor agrees to indemnify Missouri-Illinois Public Health Officials, APIC Chapter 73 and Mayo Clinic Center for Tuberculosis and their employees, volunteers, and committees from any and all claims for loss, damage, or injury. Exhibitors are encouraged to insure themselves against property loss or damage, and against both general and personal liability.
- Exhibitor understands and agrees that, for the safety of conference attendees, Exhibitor shall not perform any procedures or provide any services to conference attendees that are either invasive or are customarily performed in a practitioner's office.
